1. RESOLUTION 10-2024:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAN ANTONIO, FLORIDA (CITY), DECLARING SEVEN (7) DAYS OF LOCAL STATE OF EMERGENCY FROM HURRICANE MILTON, AND AUTHORIZING THE MAYOR TO LEAD COOPERATION WITH PASCO COUNTY OFFICIALS IN DEBRIS REMOVAL AND TO EXTEND THIS RESOLUTION IN SEVEN (7) DAY INCREMENTS PURSUANT TO SECTION 252.38(3)(a) FLORIDA STATUTES, AS NECESSARY; IN THE EVENT OF A COUNTY OR GOVERNOR’S EMERGENCY DELARATION, AUTHORIZING AND DIRECTING THE CITY MANAGER TO IMPLEMENT THE EMERGENCY DECLARATION PREPARATIONS, THE MAYOR IS AUTHORIZED TO TAKE WHATEVER PRUDENT ACTIONS MAY BE NECESSARY TO PROTECT CITY INFRASTRUCTURES AND THE HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF THE CITY AND CUSTOMERS OF THE CITY’S UTILITIES SYSTEMS PURSUANT TO THIS DECLARATION; AND PROVIDING FOR AN EFFECTIVE DATE.
